APPROVING MAP OF COLONY HOMES MIRA MESA SUBDIVISION JUN 12 1978

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by WILLIAM GREGORY CLARKE, a Licensed Land Surveyor, entitled "COLONY HOMES MIRA MESA Being a subdivision of Parcel 1 of Parcel Map No. 6202, in the City of San Diego, County of San Diego, State of California, filed in the office of the County Recorder of San Diego County on July 27, 1977.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Via Abaca, Via Banco, Via Colonia, Via Firenze, Via Forte, Garde Court, Garde Way and Garde Street for public purposes; and said streets are hereby declared to be public streets and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities as granted and shown on said map and subject to the conditions set forth thereon.
