That the use of 100,000 square feet of the San Diego Stadium parking lot by the San Diego Asebring Association, Inc. on July 8 and 9, 1978, for the purpose of staging an Auto Cross to assist the Cystic Fibrosis Foundation is hereby authorized subject to the due execution of the standard use permit therefor.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller be and he is hereby authorized to transfer the sum of \$600 from the Transient Occupancy Tax Fund 224, Contingency Reserve Program (52.99) to the San Diego Stadium Operations Fund (256) for reimbursement for the use of 100,000 square feet of the Stadium parking lot on the days and for the purpose indicated above.
