That the bid of HONEYWELL INC. is hereby accepted and the City Manager is hereby authorized to execute a contract for furnishing PREVENTIVE MAINTENANCE, REPAIR AND CALIBRATION OF INSTRUMENTS AT THE POINT LOMA WASTE WATER TREATMENT PLANT AND THE UTILITIES WASTE WATER PUMP STATION NO. 2 as may be required for a period of one (1) year beginning August 1, 1978 through July 31, 1979, per prices on file in the Purchasing Department; terms net 30 days with an option to renew contract for an additional one (1) year period at prices not to exceed 15% of bid price.
