

RESOLUTION NO. 221116

WHEREAS, a certain right of way for sewer purposes was acquired in fee for an earlier development in the Mira Mesa area now within the subdivision known as Mira Mesa West Unit No. 1; and

WHEREAS, the proposed development of the property requires abandonment of the City's existing fee title right of way; and

WHEREAS, the City will receive substitute easements where required in connection with the approval of the subdivision map of Mira Mesa West Unit No. 1; and

WHEREAS, the City has received a consideration of \$5,000 for the quitclaim of the City's fee interest; and

WHEREAS, the City has no present or prospective use for said right of way and the City Manager has recommended that the City quitclaim its interests therein; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

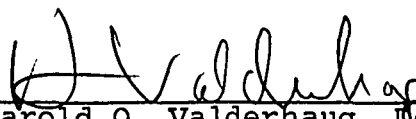
