APPROVING MAP OF STARLIGHT SUBDIVISION

JUN 13 1978

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed
by ALLEN D. RING, a Registered Civil Engineer, entitled "STARLIGHT
SUBDIVISION Being a subdivision of Lot 57 in Azure Coast
Unit No. 2 according to Map thereof No. 5676, filed January 12,
1966 and Parcel 1 of Parcel Map 394, filed November 30, 1970,
all filed in the office of the County Recorder of San Diego County,
all in the City of San Diego, County of San Diego, State of
California.", is made in the manner and form prescribed by law
and conforms to the surrounding surveys; that said map and the
subdivision of land shown thereon is hereby approved and accepted;
and said Council hereby accepts on behalf of the public Starlight
Drive for public purposes; and said street is hereby declared
to be a public street and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on
behalf of The City of San Diego, a municipal corporation, the
easements with the right of ingress and egress for the construction
and maintenance of sewer and drainage facilities as granted and
shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to
endorse upon said map, as and for the act of the Council, that
said Council has approved said subdivision map and that said
public street is accepted on behalf of the public as heretofore


