

RESOLUTION NO. 221128

WHEREAS, there is general agreement among United States and Mexican Federal, State and local governments that a second international crossing between San Diego and Tijuana is necessary to serve the auto and commercial traffic between the two countries; and

WHEREAS, there is agreement that this border crossing should be located on Otay Mesa/Mesa de Otay at Harvest Road; and

WHEREAS, land use plans and developments on both sides of the border are predicated on the opening of the second border crossing; and

WHEREAS, there is agreement that the border crossing facility could be constructed and open as soon as roads to the crossing are constructed; and

WHEREAS, in 1973 and 1976 the City Council passed Resolution Nos. 209041, 209042 and 217234 whereby the Council recongized the need for an additional border crossing on Otay Mesa at the point easterly of Brown Field and the Tijuana Airport; and

WHEREAS, the City Council continues to recognize the need for and supports an additional border crossing on Otay Mesa; and

WHEREAS, on February 8, 1978 the Council authorized the transfer of \$30,000 within the Gas Tax Reserve Fund to CIP 52-140 and the expenditure of these funds solely and exclusively for the purpose of advancing the Preliminary design phase of Otay Mesa Road for the Fiscal Year 1979 budget to the Fiscal Year 1978 budget; and

WHEREAS, the Comprehensive Planning Organization Board of Directors approved Resolution 77-128 requesting interstate designation of State Route 117 from Interstate 805 to the border as impetus to the necessary road development to serve the border crossing; and


WHEREAS, the Comprehensive Planning Organization has prepared a Report summarizing past and current activities relevant to the development and opening of a second border crossing, including the issue of roads; NOW, THEREFORE,

BE IT RESOLVED, that the City Council accept the Report titled "International Border Crossing: Otay Mesa/Mesa de Otay," a copy of which is on file in the office of the City Clerk as Document No. 763815, amended as indicated in a memo from James L. Goff, City Planning Director to the Transportation and Land Use Committee dated May 26, 1978, a copy of which is on file in the office of the City Clerk as Document No. 763816, and adopt the Recommendations attached.

BE IT FURTHER RESOLVED, that the City's Comprehensive Planning Organization's delegate be and he is directed to support said Report and Recommendations, as amended.

BE IT FURTHER RESOLVED, that the Report and Recommendations be submitted to the appropriate Federal, State and local governments acting in the second border crossing development for their action in funding the project.
