

RESOLUTION No. 221133 (R- 78-2383)

Adopted on JUN 13 1978

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the SAN DIEGO BOWL GAME ASSOCIATION for the conduct of the "Holiday Bowl" post-season college football game to be held in December of 1978, under the terms and conditions set forth in the agreement on file in the office of the City Clerk as Document No. 763823.

BE IT FURTHER RESOLVED, that the provisions of Council Policy No. 100-3 which stipulate that events funded pursuant to that policy must be free of charge (paragraph A.3.) and which prohibit the buildup of reserves (paragraph B.1.) are hereby waived for this agreement.

BE IT FURTHER RESOLVED, that the City Manager is hereby directed to include the minimum rental fee of twenty-five hundred dollars (\$2,500) in the Single Use Permit negotiated with the San Diego Bowl Game Association.
