
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that street easement and drainage easement deed of LEONARD H. McROSKEY as sole trustee under Leonard H. McRoskey and Virginia McRoskey Trust of July 27, 1967, and JOHN W. McROSKEY and CATHERINE McROSKEY, executed in favor of The City of San Diego, bearing date of April 10, 1978, conveying to said City an easement for a right of way for a public street and incidents thereto, together with an easement for a right of way for the construction, operation and maintenance of a storm drain and appurtenances thereto, through, over, under, along and across all that portion of Pueblo Lot 1301 of the Pueblo Lands of San Diego, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed as Parcels 1-1 and 1-3 is hereby dedicated as and for a public street, and the same is hereby named NOBEL DRIVE; and the land therein conveyed as Parcel 1-2 is hereby dedicated as and for a public street, and the same is hereby named REGENTS ROAD.

That the City Clerk shall cause a certified copy of this resolution attested by him under seal, to be recorded in the office of the County Recorder.
