BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that street easement deed of FIRST CENTENNIAL TITLE COMPANY, INC., a corporation, as Trustee under Holding Agreement No. 1002, executed in favor of The City of San Diego, bearing date of March 9, 1978, conveying to said City an easement for a right of way for a public street and incidents thereto in all that portion of Pueblo Lot 1301 of the Pueblo Lands of San Diego, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed as Parcel 4-1 is hereby dedicated as and for a public street, and the same is hereby named REGENTS ROAD.

That the City Clerk shall cause a certified copy of this resolution attested by him under seal, to be recorded in the office of the County Recorder.
