

RESOLUTION No. 221151 (R- 78-2378)

Adopted on JUN 19 1978

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that street easement deed of HENRY BOOKSPAN and SOPHIE BOOKSPAN, husband and wife as joint tenants, executed in favor of The City of San Diego, bearing date of March 9, 1978, conveying to said City the permanent easement and right of way for a public street and incidents thereto, over, under, upon, along and across all those portions of Lots A-79 and A-80 of San Ysidro, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed as Parcel 1 is hereby dedicated as and for a public street, and the same is hereby named SEAWARD AVENUE, and the land therein conveyed as Parcel 2 is hereby dedicated as and for a public street and the same is hereby named COTTONWOOD ROAD.

That the City Clerk shall cause a certified copy of this resolution attested by him under seal, to be recorded in the office of the County Recorder.


