

RESOLUTION No. 221154 (R-78-2379)



BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that street easement deed of the DIOCESE OF SAN DIEGO EDUCATION AND WELFARE CORPORATION, a corporation, executed in favor of The City of San Diego, bearing date of April 12, 1978, conveying to said City the permanent easement and right of way for a public street and incidents thereto, over, under, upon, along and across all those portions of Lots A-85, A-1 and A-2 of San Ysidro, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed as Parcel 1 is hereby dedicated as and for a public street, and the same is hereby named WEST PARK AVENUE, and the land therein conveyed as Parcel 2 is hereby dedicated as and for a public street, and the same is hereby named SEAWARD AVENUE.

That the City Clerk shall cause a certified copy of this resolution attested by him under seal, to be recorded in the office of the County Recorder.
