


RESOLUTION No. 221169 (R-78-2393)

That the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a Revocable Permit with the SAN PASQUAL UNION SCHOOL DISTRICT, a body politic, as Permittee, for the purpose of location and drilling of a well to supply the San Pasqual Public School with water from the Santa Ysabel River, under the terms and conditions set forth in that permit on file in the office of the City Clerk as Document No. 763887.
