That the City Manager is hereby authorized and empowered to do by City Forces all the work of performing operational checks, to make connections where required and highline existing water services as required in connection with CONSTRUCTION OF SEWER MAIN REPLACEMENT GROUP 42-MISSION BEACH AREA pursuant to recommendation of the City Manager and submission of estimates by him indicating that said work can be done by the City Forces more economically than if let by contract. The cost of said work shall not exceed \$15,111.
