

RESOLUTION NO. 221187

WHEREAS, The City of San Diego and County of San Diego are desirous of jointly acquiring, developing and operating the Lake Murray/Cowles/Fortuna Mountain Regional Park for the benefit of all citizens and visitors of the City and County of San Diego; and

WHEREAS, the Reynolds Environmental Group has prepared a Master Development Plan Report which recommends tentative boundaries and lands to be acquired for Lake Murray/Cowles/Fortuna Mountain Regional Park; and

WHEREAS, the City Council adopted Resolution No. 219089 on August 17, 1977, authorizing and directing the City Manager to acquire public and privately owned land for the Lake Murray/Cowles/Fortuna Mountain Regional Park, as recommended in the Reynolds Environmental Group Report; and

WHEREAS, certain areas proposed for inclusion into the regional park are located within the boundaries of the Elliott or Navajo Community Plans; and

WHEREAS, the Elliott and Navajo Community Plans were drafted prior to the completion of the Master Development Plan Report for Lake Murray/Cowles/Fortuna Mountain Regional Park; and

WHEREAS, the Elliott and Navajo Community Plans recommend residential, commercial or other nonpark uses for some of the areas proposed for inclusion into the regional park; and

WHEREAS, the Open Space Element of the General Plan of San Diego does not designate all the land recommended by the Reynolds Report for inclusion in the regional park; and

WHEREAS, on October 13, 1977 the Lake Murray/Cowles/Fortuna Mountain Regional Park Task Force recommended that local community plans and Open Space Element of the General Plan be brought into conformance with the proposed regional park;

NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Planning Director is hereby directed to take all steps necessary to expeditiously initiate proceedings to determine whether the Elliott and Navajo Community Plans and The City of San Diego General Plan should be amended to change the regional park boundaries in conformance with the Master Development Plan Report for Lake Murray/Cowles/Fortuna Mountain Regional Park.
