

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the offer of DYNECO, INC. is hereby accepted and the City Manager is hereby authorized to execute a contract for the PURCHASE AND INSTALLATION OF TWO (2) EACH AQUA GUARD MODEL SK-S-T-X SELF CLEANING SCREEN SYSTEMS AND AUXILIARY EQUIPMENT for a total cost of \$173,020.00; terms net 30 days, plus sales tax, plus an estimated freight charge of \$8,000.00, plus an estimated installation charge of \$550.00.
2. Authorizing the expenditure of \$191,951.20 from Sewer Revenue Fund 506 and transferring within the 506 Fund said sum from the unallocated reserve (69.97) to Point Loma Treatment Plant Operations (62.25) for the above purpose.
