
Adopted on JUN 26 1978

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that street easement deed of the SAN DIEGO GAS & ELECTRIC COMPANY, a corporation, executed in favor of The City of San Diego, bearing date of June 6, 1978, conveying to said City, an easement and right of way for public street and utility purposes and incidents thereto, through, over, under and across those portions of Pueblo Lot 1103 of the Pueblo Lands of San Diego, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed as Parcel 1 is hereby dedicated as and for a public street, and the same is hereby named CIRRUS STREET; and the land therein conveyed as Parcel 2 is hereby dedicated as and for a public street, and the same is hereby named CUMULUS LANE.

That the City Clerk shall cause a certified copy of this resolution attested by him under seal, to be recorded in the office of the County Recorder.
