
Adopted on JUN 26 1978

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that street easement deed of DONALD L. BREN COMPANY, a California corporation, executed in favor of The City of San Diego, bearing date of March 8, 1978, conveying to said City the permanent easement and right of way for a public street and incidents thereto, over, under, upon, along and across all that portion of Parcel 2 of Parcel Map 6810 as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named EVENING WAY.

That the City Clerk shall cause a certified copy of this resolution attested by him under seal, to be recorded in the office of the County Recorder.
