WHEREAS, an application for two (2) additional limited certificates of public convenience and necessity from the POWAY RANCHO BERNARDO CAB CO. to operate taxicabs within the City of San Diego has been received; and

WHEREAS, on July 5, 1974, the Poway Rancho Bernardo Cab Co. was granted two limited taxicab certificates for a period of one year to provide taxicab service to the Rancho Bernardo and Penasquitos areas; and

WHEREAS, on October 2, 1975, the above operating authorization for Poway Rancho Bernardo Cab Co. was renewed for the Rancho Bernardo-Penasquitos area for an indefinite period of time, and is currently in force; and

WHEREAS, the Poway Rancho Bernardo Cab Co. requests that its presently authorized geographic operating area be expanded to include the Mira Mesa and Scripps Ranch areas; and

WHEREAS, pursuant to Section 72.0101(d) of the San Diego Municipal Code, the City Manager has caused an investigation to be made and has reported his findings in writing to this Council; and

WHEREAS, his report indicates, among other things, that the applicant's, Poway Rancho Bernardo Cab Co., owners are Charles R. Hipkins, June W. Hipkins and Betty E. Weckback, whose character and fitness recommend them to engage in the business of operating taxicabs; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the Poway Rancho Bernardo Cab Co., having filed an application for two additional limited certificates of public convenience and necessity to operate taxicabs pursuant to the provisions of Section 72.0101(m) of the San Diego Municipal Code, and the City Manager having conducted the required investigation, two additional limited certificates of public convenience and necessity are hereby granted to the Poway Rancho Bernardo Cab Co. to operate the vehicles specified in the application, limited to the pickup areas of Mira Mesa and Scripps Ranch, as indicated on the attached map, in addition to the present authorized operating area of Rancho Bernardo-Penasquitos, subject to compliance with all provisions of the San Diego Municipal Code.

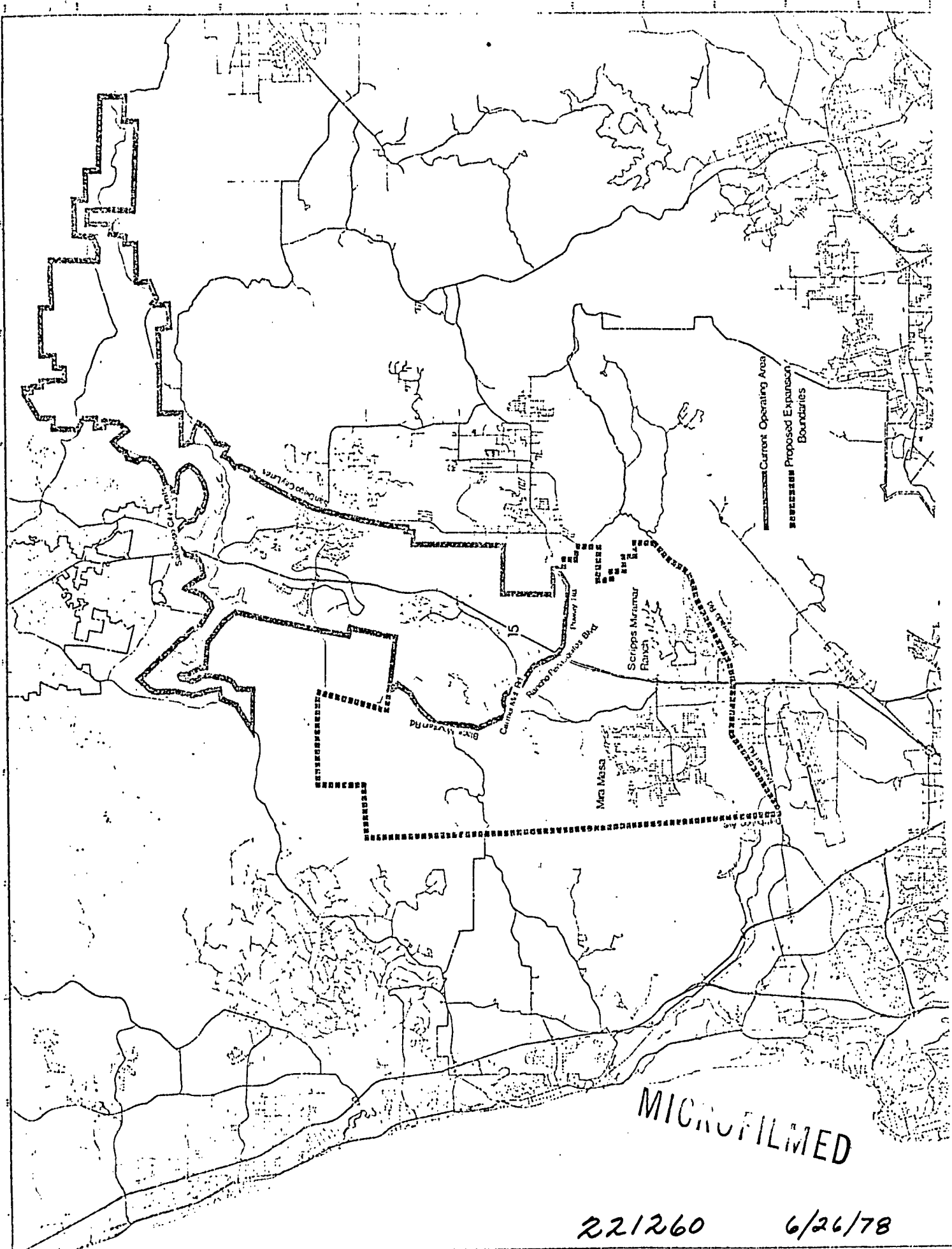
