BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be, and he is hereby authorized and empowered to negotiate and execute, for and on behalf of said City, an agreement with the San Ysidro Elementary School District for the purpose of operating a senior nutrition program at one site, La Mirada School, to provide hot lunches for home-bound seniors in the San Ysidro area, for the period from July 1, 1978 through June 30, 1979.

BE IT FURTHER RESOLVED, that the expenditure of \$22,200 is hereby authorized out of Human Care Services Fund 267 of The City of San Diego, solely and exclusively, for the purpose of providing funds for the above referenced services.
