That the City Manager, be and he is hereby authorized and empowered to negotiate and execute, for and on behalf of said City, an agreement with The County of San Diego, to provide a 20% local match on behalf of the community agency engaged by the County to operate a senior nutrition program in the downtown area of San Diego.

BE IT FURTHER RESOLVED, that the expenditure of \$9,970 is hereby authorized out of Human Care Services Fund 267 of The City of San Diego, solely and exclusively, for the purpose of providing funds for the above referenced services.
