WHEREAS, pursuant to the Operating Agreement between The City of San Diego and San Diego Transit Corporation ("Transit Corporation"), Transit Corporation has duly submitted its budget for the operation of the public transportation system in the City of San Diego and its environs for fiscal year 1978-1979; and

WHEREAS, said budget contemplates a five cent (5¢) fare increase during fiscal year 1978-1979 on the basic fare; and

WHEREAS, a decision of the Court of Appeals of the State of California indicates that an Environmental Impact Report, in accordance with provisions of the California Environmental Quality Act, is required for implementation of said fare increase; and

WHEREAS, Section 21060.3 of the California Environmental Quality Act provides that action may be taken by the legislative body in the absence of an Environmental Impact Report under certain emergency conditions; and

WHEREAS, an Environmental Impact Report concerning this proposed rate increase is being prepared and will be final in August 1978; and

WHEREAS, the passage of Proposition 13 on the June 6 Ballot has caused a sudden and unexpected decrease in the financial assistance available for public transit purposes; and

WHEREAS, the City Council must take immediate action to approve the newly proposed budget to avoid a discontinuity in the essential public services provided by Transit Corporation; and

WHEREAS, the City Council desires to fully consider the environmental documents already in process, thereby allowing full consideration of all feasible alterations and mitigating measures at the time of approval of a final budget for Transit Corporation; and

WHEREAS, Transit Corporation proposes to submit a revised budget in August 1978, which will be the subject of further Council action at that time; NOW, THEREFORE,
