
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That pursuant to the provisions of Municipal Code Sections 22.0902, 22.0902.1, and 22.0905 all bids received for the proposed sale of a portion of Lot 21 of City of San Diego Industrial Park Unit No. 4 are hereby rejected.

BE IT FURTHER RESOLVED, that no broker's fees claimed in connection with any of said bids shall be paid.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and directed to readvertise for new bids on said property, conduct a public auction on June 5, 1978 to solicit bid proposals to purchase said property, and to bring the proposed highest bid to purchase said property to the City Council for its acceptance or rejection on June 5, 1978.
