2. That the City Auditor and Comptroller is hereby authorized to transfer \$50,000 from Park and Recreation Bond Fund Reserve (725) to CIP 22-001(7).
3. That the City Auditor and Comptroller is hereby authorized to transfer \$50,000 from CIP 22-001(7) to the Capital Outlay Fund Reserve CIP 90-245.
