

RESOLUTION NO. 221290 (R.78-2071)

WHEREAS, The City of San Diego is the owner of a portion of Section 32, Township 12 South, Range 2 West, SBBM; and

WHEREAS, the herein described property is surplus to City needs; and

WHEREAS, The City desires to negotiate the sale of said property to SCRIPPS MESA VILLAGE, a limited partnership, under the provisions of Section 22.0902 of the San Diego Municipal Code, which permit the sale of real property belonging to The City of San Diego by negotiation; and

WHEREAS, the sale of this parcel may reasonably be accomplished by negotiation with the adjacent property owner because of its irregular shape; and

WHEREAS, the value of the property, as determined by an Independent Fee Appraisal, is the sum of Nineteen Thousand Dollars (\$19,000); and

WHEREAS, no real estate broker's commission shall be paid; and

WHEREAS, the sale of the aforementioned property is consistent with the public interest; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That that certain real property described in that quitclaim deed on file in the office of the City Clerk as Document No. 764039, be, and the same is hereby determined to be surplus and is hereby authorized to be sold

by negotiation for the sum of Nineteen Thousand Dollars (\$19,000) to SCRIPPS MESA VILLAGE, a limited partnership, with COLLINS PROPERTY COMPANY, as general partner.

2. That the Mayor and the City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, which is on file in the office of the City Clerk as Document No. 764039, quitclaiming to SCRIPPS MESA VILLAGE, a limited partnership, as more particularly described in said quitclaim deed.

3. That no broker's commission shall be paid by City on the herein-described negotiated sale.

4. That the City Clerk of said City is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Property Director for further handling.
