WHEREAS, The City of San Diego is the owner of a JUN $2.8\,$ 1978 portion of Section 32, Township 12 South, Range 2 West, SBBM; and

WHEREAS, the herein described property is surplus to City needs; and

WHEREAS, The City desires to negotiate the sale of said property to FRANK S. and BARBARA M. WATTS, husband and wife, as community property, the adjacent property owner, under the provisions of Section 22.0902 of the San Diego Municipal Code, which permit the sale of real property belonging to The City of San Diego by negotiation; and

That the Mayor and the City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, which is on file in the office of the City Clerk as Document No. 764036 , quitclaiming to FRANK S. and BARBARA M. WATTS, husband and wife, as community property, the adjacent property owner, as more particularly described in said quitclaim deed.
- 3. That no broker's commission shall be paid by City on the herein-described negotiated sale.
- 4. That the City Clerk of said City is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Property Director for further handling.
