WHEREAS, an application for one (1) additional limited certificate of public convenience and necessity from ROLLAND and EVELYN STOKES, dba ARRO CAB CO., to operate a taxicab within the City of San Diego has been received; and

WHEREAS, in September, 1977, Arro Cab Co. was granted two limited taxicab certificates to provide taxicab service to the unincorporated areas of Leucadia, Encinitas, Cardiff, Solana Beach and Rancho Santa Fe; and

WHEREAS, in December, 1977, Arro Cab Co. was granted a limited taxicab certificate to provide taxicab service to the City of Del Mar; and

WHEREAS, Rolland and Evelyn Stokes request that their presently authorized geographic operating area be expanded to include the following:

- (1) Northern Boundary - San Diego city boundary eastward to the intersection of Black Mountain Road;
- (2) Southern Boundary - From the intersection of I-5 and Genesee Avenue eastward along Genesee and a straight line from the end of Genesee to the Pacific Ocean;
- (3) Eastern Boundary - Black Mountain Road to Carmel Valley Road to the junction of Shaw Valley Road on a straight line southward to the junction of I-5 with I-805 south on I-5 to Genesee Avenue;
- (4) Western Boundary - The Pacific Ocean to Del Mar and the San Diego city border; and


WHEREAS, the Council this date has found the contents of the City Manager's report to be correct and accurate; NOW, THEREFORE,
