APPROVING MAP OF HAGEN TERRACE SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

Said Council hereby finds that that certain map surveyed by BYRL D. PHELPS, a Registered Civil Engineer, entitled "HAGEN TERRACE Being a subdivision of Lots 3 and 4, Block 8 and Lot 5, Block 9 of amended map showing Silver Terrace, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 695, filed in the office of the County Recorder of San Diego County, December 12, 1891, together with Brunner Street.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easement with the right of ingress and egress for the construction and maintenance of water and sewer facilities as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that that certain easement for water and sewer facilities, as granted and shown on said map, is accepted on behalf of The City of San Diego, as above stated.
