That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an Amendment to Agreement with the SAN DIEGO UNIFIED SCHOOL DISTRICT for the turfing of the Hardy School Playground, on file in the office of the City Clerk as Document No. 763950.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller be and he is hereby authorized to transfer the sum of \$14,000 from Capital Outlay Fund Unallocated Reserve (CIP-245) to Cooperative Park Projects (CIP 20-008); and the expenditure of said \$14,000 is hereby authorized from Capital Outlay Fund 245 (CIP 20-008) for the sole and exclusive purpose of providing funds for the San Diego Unified School District to turf the Hardy School Playground.
