1. That the bid of \$498,021.00 by CHRISTEVE CORP., a corporation, for the CONSTRUCTION OF SEWER MAIN REPLACEMENT GROUP 45 - NORTH PARK AREA in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 763370.
2. That the City Auditor and Comptroller is hereby authorized to transfer \$160,600 within the Sewer Revenue Fund 506 from the Unallocated Reserve (6997) to Sewer Construction Outlay (64.92) for this purpose and related costs.
