BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the low acceptable bid of MULTISONICS INC. is hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of ONE (1) TRAFFIC SIGNAL CONTROLLER UNIT AND THIRTEEN (13) TRAFFIC SIGNAL CONTROL ASSEMBLIES at a total cost of \$128,445.00 plus sales tax.
2. That the City Auditor and Comptroller is hereby authorized to transfer \$9,800 from CIP 90-245 Capital Outlay Funds Reserve to CIP 62-123 and \$7,200 from CIP 90-245 Capital Outlay Funds Reserve to CIP 61-136 and \$8,500 from CIP 90-245 Capital Outlay Funds Reserve to CIP 62-131 and \$10,700 from CIP 90-245 from Capital Outlay Funds Reserve to CIP 61-134 and \$6,700 from CIP 90-245 Capital Outlay Funds Reserve to CIP 62-128 and \$15,700 from CIP 90-245 Capital Outlay Funds Reserve to CIP 62-127.
