BE IT FURTHER RESOLVED, that a Capital Improvement Project entitled, "Miscellaneous Bikeway Improvements," which was to be funded from annual allocation Capital Improvement Projects 58-004 and 58-075, is hereby deferred.

BE IT FURTHER RESOLVED, that the purchase of microwave equipment for Capital Improvement Projects 37-125 and 37-126 is hereby deferred.
