Said Council hereby finds that that certain map surveyed by WILLIAM B. RICK, a Registered Civil Engineer, entitled "CAMBRIDGE Being a subdivision of Parcel 2 of Parcel Map No. 5597, in the City of San Diego, County of San Diego, State of California, according to Map thereof on file in the office of County Recorder of San Diego County, being a division of Parcel 2 of Parcel Map No. 5323, filed in the office of County Recorder of San Diego County, as said parcel maps were corrected by Certificate of Corrections recorded November 16, 1977 as File/Page Nos. 77-474591 and 77-474592.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Morning Way for public purposes; and said street is hereby declared to be a public street and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, the easements listed in paragraphs (1) and (2) of the Owner's certificate, as shown on this map and subject to the conditions set forth thereon.


