
WHEREAS, the City has received a consideration of \$260

that the Mayor and the City Clerk are hereby authorized and
empowered to execute, for and on behalf of The City of
San Diego, a quitclaim deed, the form of which is on file
in the office of the City Clerk as Document No. 764065,
quitclaiming to Sunburst Homes Corporation, a California
corporation, all the City's right, title and interest in the
slope easement, as more particularly described in said form of
quitclaim deed.
