BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the petition for the improvement of the ALLEY in BLOCK 1, TURNER'S SEASHELL PARK & CROWN POINT (between Riviera Drive and Haines Street and Moorland Drive and La Playa Avenue), under the provisions of the California Improvement Act of 1911, consisting of three sheets and filed under Document No. 764071, is hereby granted.

BE IT FURTHER RESOLVED, that the City Manager be, and he is hereby directed to prepare plans, drawings, typical cross-sections, profiles and specifications for the improvement of the ALLEY in BLOCK 1, TURNER'S SEASHELL PARK & CROWN POINT, in the City of San Diego, by grading and paving the alley section, together with estimates of the costs and expenses of such work and to furnish this Council with a description of the district to be included in the assessment for the work and improvements hereinabove mentioned.
