WHEREAS, The City of San Diego is the owner of that certain unrecorded right-of-way for pipe lines affecting Parcel 1 of Parcel Map No. 2271; and

WHEREAS, SOLANA BEACH PROPERTIES, a limited partnership, owner of the land affected by said right-of-way has requested that the City quitclaim to them its interest in and to said right-of-way to allow better utilization of the land; and

WHEREAS, the City desires to negotiate the sale of said right-of-way to SOLANA BEACH PROPERTIES, a limited partnership, under the provisions of Section 22.0902 of the San Diego Municipal Code, which permit the sale of real property belonging to The City of San Diego by negotiation; and

WHEREAS, the sale of such an interest in real property as this may reasonably be accomplished by negotiation; and

WHEREAS, the value of the property right sought, as determined by a staff appraiser of said City, is the sum of Seventy Dollars (\$70); and

WHEREAS, no real estate broker's commission shall be paid; and

WHEREAS, the sale of the aforementioned property right is consistent with the public interest; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:



- 1. That that certain real property right described in that quitclaim deed on file in the office of the City Clerk as Document No. 764088 , be, and the same is hereby authorized to be sold by negotiation for the sum of Seventy Dollars (\$70) to SOLANA BEACH PROPERTIES, a limited partnership.
- 3. That no broker's commission shall be paid by City on the herein described negotiated sale.
- 4. That the City Clerk of said City is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Property Director for further handling.
