BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager is hereby authorized and empowered to execute a Tideland Use and Occupancy Permit with the SAN DIEGO UNIFIED PORT DISTRICT, a public corporation, whereby Port permits City to utilize 65,809 square feet of vacant land for a parking facility to serve the San Diego Police Department, for a one year period commencing July 1, 1977 and ending June 30, 1978, at a monthly rental of \$1,206, under the terms and conditions set forth in said permit on file in the office of the City Clerk as Document No. '7641'71.


