BE IT FURTHER RESOLVED, that the expenditure of \$2,528 be hereby authorized out of Revenue Sharing Fund 267 of The City of San Diego solely and exclusively for the above purpose, contingent upon approval of Fiscal Year 1979 Revenue Sharing allocation.
