

RESOLUTION NO. 221376 (R. 78-2226)

VACATION OF GAINES STREET BETWEEN AZUSA  
AND BENICIA STREETS

JUL 11 1978

WHEREAS, it is proposed that GAINES STREET BETWEEN  
AZUSA AND BENICIA STREETS be vacated; and

WHEREAS, there is no present or prospective use for the  
street either for the public street system for which the  
right-of-way was originally acquired or for any other public  
use of a like nature that can be anticipated in that the  
street is now used primarily for access to adjacent properties  
and the general circulation within the immediate community  
will not be impaired by the closure of this portion of  
Gaines Street; and

WHEREAS, the public will benefit from the vacation  
through improved utilization of land; and

WHEREAS, the vacation or abandonment is not incon-  
sistent with the General Plan or an approved Community Plan;  
and

WHEREAS, the public street system for which the right-  
of-way was originally acquired will not be detrimentally  
affected by this vacation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San  
Diego, California, that GAINES STREET BETWEEN AZUSA AND  
BENICIA STREETS, as more particularly referred to in Resolution  
of Intention No. 220962, is unnecessary for present  
or prospective public street purposes.





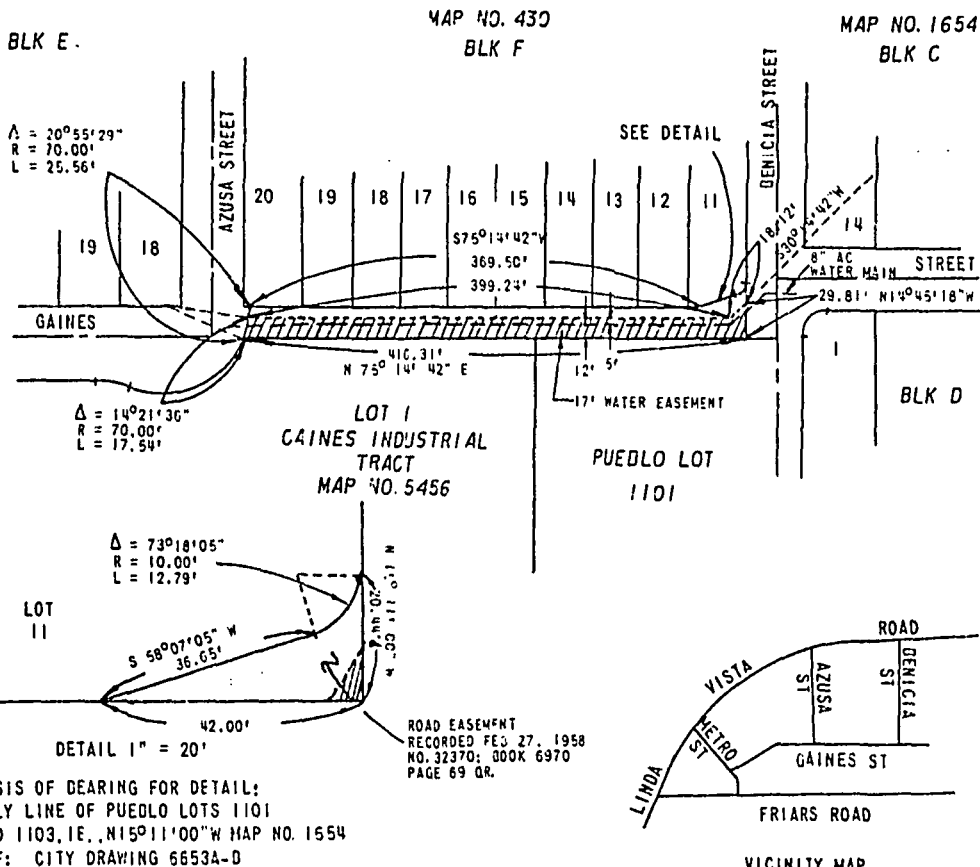
BASIS OF BEARINGS:
