

RESOLUTION NO. 221378 (R.78-2230)

VACATION OF PALM AVENUE AT TWINING AVENUE JUL 11 1978

WHEREAS, it is proposed that PALM AVENUE AT TWINING AVENUE be vacated; and

WHEREAS, there is no present or prospective use for the street either for the public street system for which the right-of-way was originally acquired or for any other public use of a like nature that can be anticipated in that the unused dedication is surplus to the City's needs; and

WHEREAS, the public will benefit from the vacation through improved utilization of land; and

WHEREAS, the vacation or abandonment is not inconsistent with the General Plan or an approved Community Plan; and

WHEREAS, the public street system for which the right-of-way was originally acquired will not be detrimentally affected by this vacation; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, California, that PALM AVENUE AT TWINING AVENUE, as more particularly referred to in Resolution of Intention No. 221021, is unnecessary for present or prospective public street purposes.
