

RESOLUTION NO. 221379 (R.78-2228)

VACATION OF MILDRED STREET BETWEEN BRUNNER AND EUREKA STREETS JUL 11 1978

WHEREAS, it is proposed that MILDRED STREET BETWEEN BRUNNER AND EUREKA STREETS be vacated; and

WHEREAS, there is no present or prospective use for the street either for the public street system for which the right-of-way was originally acquired or for any other public use of a like nature that can be anticipated in that considerable fill would be necessary for the street to be improved and the slope rights would be unobtainable and the adjacent property owners have requested the street vacation so they may develop their properties to the fullest potential; and

WHEREAS, the public will benefit from the vacation through improved utilization of land; and

WHEREAS, the vacation or abandonment is not inconsistent with the General Plan or an approved Community Plan; and

WHEREAS, the public street system for which the right-of-way was originally acquired will not be detrimentally affected by this vacation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, California, that MILDRED STREET BETWEEN BRUNNER AND EUREKA STREETS, as more particularly referred to in Resolution of Intention No. 221020, is unnecessary for present or prospective public street purposes.



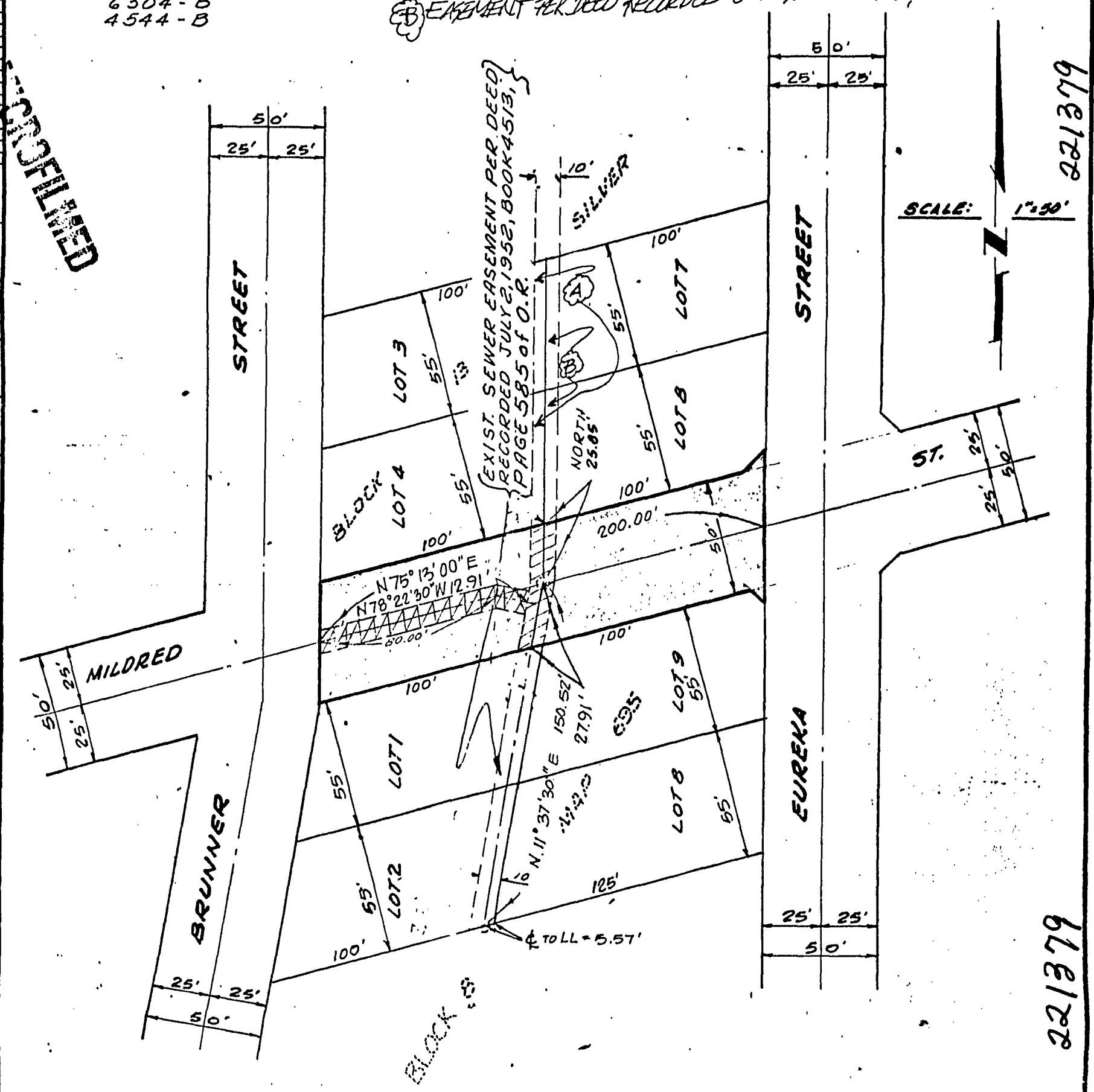

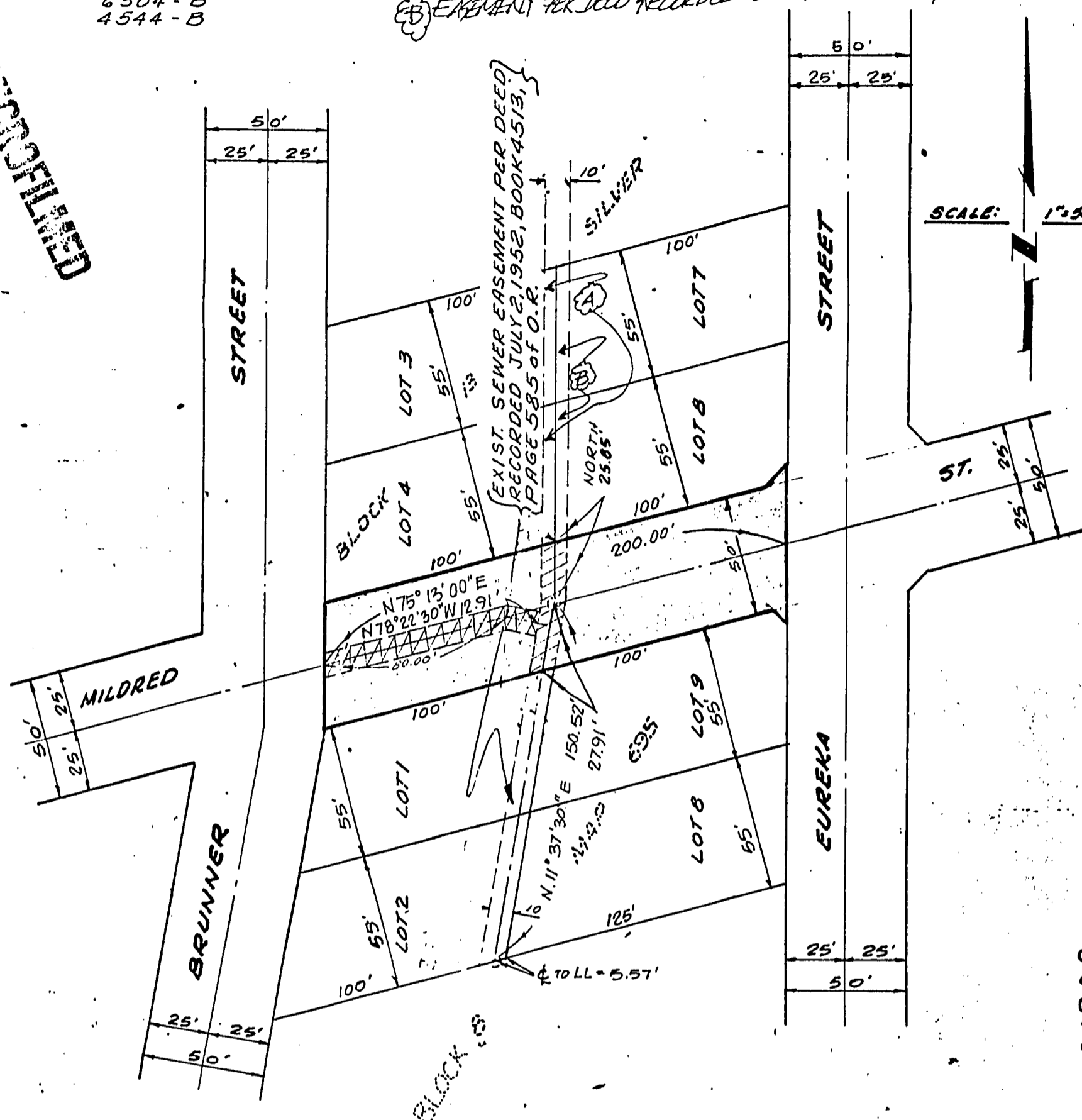
