BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

1. That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with KGB INCORPORATED for the development of a soccer field in the Morley Field East area of Balboa Park, on file in the office of the City Clerk as Document No. 764199.

2. That the City Manager hereby accepts the generous contribution of \$62,000 from KGB Incorporated and directs that said contribution be deposited in Capital Outlay Fund 245, CIP 20-008, Cooperative Park Projects, to be used exclusively for the purpose of developing a soccer field in the Morley Field East area of Balboa Park.

3. That the expenditure of \$18,600 from Capital Outlay Fund 245, CIP 20-008, Cooperative Park Projects, is hereby authorized solely and exclusively for the City's share of the development of said soccer field.

4. That this Council does hereby commend KGB Incorporated for this act of civic generosity and does hereby publicly express on behalf of the citizens of this City a debt of gratitude to KGB Incorporated.

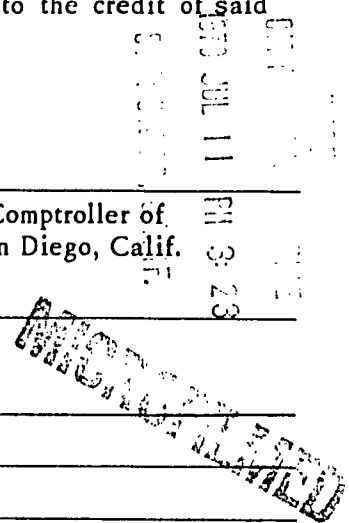
