

WHEREAS, the Planning Commission held a public hearing on June 8, 1978, to consider the revised Scripps Miramar Ranch Community Plan; and

WHEREAS, the Planning Commission approved and recommended to the City Council adoption of the revised Scripps Miramar Ranch Community Plan; and

WHEREAS, City Council Policy 600-7, requires that public hearings to consider revisions of the "Progress Guide and General Plan" for the City of San Diego shall be scheduled concurrently with all public hearings on proposed community plans; and

WHEREAS, the Planning Commission of The City of San Diego has held a concurrent public hearing to consider the revised Scripps Miramar Ranch Community Plan and amendment of the General Plan in order to retain consistency between said plans; and

WHEREAS, on June 8, 1978, the Planning Commission adopted and recommended for adoption by the City Council an amended General Plan; and

WHEREAS, California Government Code, Section 65860, provides that mandatory elements of the General Plan may not be amended more than three times per year; and

WHEREAS, it is the intention of the City Council to consider amendments to the "Progress Guide and General Plan for the City of San Diego" at hearings conducted on a semi-annual basis; and


WHEREAS, the Council of The City of San Diego held a public hearing to consider the revised Scripps Miramar Ranch Community Plan; NOW, THEREFORE,

That the revised SCRIPPS MIRAMAR RANCH COMMUNITY PLAN shall be rescinded upon adoption of an appropriate amendment to the "Progress Guide and General Plan for the City of San Diego," incorporating said plan, an omnibus hearing on this and other amendments having been scheduled on or about July 25, 1978.
