

RESOLUTION NO. 221403 JUL 18 1978
(R. 78-2076)

WHEREAS, the approximate 100-foot long alley between 42nd Street and San Pasqual Street in San Miguel Terrace, Map 3143, is presently being used as a shortcut between 42nd Street and Logan Avenue via San Pasqual Street; and

WHEREAS, currently motorists are traveling at speeds much higher than the required 15 MPH speed limit in alleys; and

WHEREAS, the request for this action was made by the residents in the area who are concerned with public safety; and

WHEREAS, City staff evaluation indicated that the closure and gating of the alley would provide minimum inconvenience to the residents and will not hinder emergency activity in the area; and

WHEREAS, the gate can be opened to allow through traffic by emergency vehicles if necessary; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. Pursuant to Section 21101(a) of the Vehicle Code of the State of California, that portion of the alley between 42nd Street and San Pasqual Street in San Miguel Terrace, Map 3143, which portion is shown on the drawing on file in the office of the City Clerk as Document No. 764182 is determined to be no longer needed for motor vehicle traffic and said portion of the alley is hereby closed to such vehicles.


