BE IT RESOLVED, by the Council of The City of San Diego as follows:

That Change Order No. 1, dated June 21, 1978, heretofore filed with the City Clerk of said City as Document No. 764169 issued in connection with the contract between The City of San Diego and Viewland Construction Company for CONSTRUCTION OF SOLEDAD MOUNTAIN WATER PUMP PLANT, said contract having been filed in the office of the City Clerk as Document No. 759302, be and the same is hereby approved; and the changes therein set forth, amounting to an increase in the contract price of \$15,225 and an extension of time of 201 days extending the completion date to August 1, 1978, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the expenditure of \$5,225 be hereby authorized out of Water Utilities Fund 502 of The City of San Diego, solely and exclusively, for the purpose of providing funds for the above project, and supplementing Resolution No. 218034 in that amount as the City's contribution to the added cost of the project.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to transfer the sum of \$5,225 within Water Revenue Rund 502 from Unallocated Reserve (69.79) to Water Construction Outlay (63.19).
