BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the City Auditor and Comptroller be and he is hereby authorized to transfer \$15,650 and \$12,850 from CIP 90-220 (Unallocated Reserve) and the remaining funds approved by Resolution No. 208280, adopted June 28, 1973, respectively, to CIP 52-098.3 (Mira Mesa Boulevard Project) of The City of San Diego, and that expenditure of said funds is hereby authorized solely and exclusively for the purpose of providing funds for the following professional services.

2. That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with E. F. Cook & Associates Ltd., a California corporation, to provide professional engineering services in connection with the construction of Mira Mesa Boulevard from I-805 to Parkdale Avenue, in The City of San Diego, under the terms and conditions set forth in the agreement on file in the office of the City Clerk as Document No. 764170.


