APPROVING MAP OF MIRADOR UNIT NO. 4 SUBDIVISION
AND ACKNOWLEDGING RECEIPT OF SUBDIVIDER'S ASSURANCE
OF COMPLIANCE WITH THE AFFIRMATIVE MARKETING PROGRAM.

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed
by W. R. NOTHOMB, a Licensed Land Surveyor, entitled "MIRADOR
UNIT NO. 4 Being a subdivision of a portion of Section 25,
Township 14 South, Range 3 West, San Bernardino Meridian,
in the City of San Diego, County of San Diego, State of
California, according to United States Government Survey.",
is made in the manner and form prescribed by law and conforms
to the surrounding surveys; that said map and the subdivision
of land shown thereon is hereby approved and accepted; and
said Council hereby accepts on behalf of the public, the
following: Jagross Court, Nalco Street, Scannell Court and
the walkways, for public purposes; and said streets and
walkways are hereby declared to be public streets and public
walkways and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts
on behalf of The City of San Diego, a municipal corporation,
any and all abutters' rights of access in and to Camino Ruiz,
adjacent and contiguous to Lots 670, 671, 672, 673, 699,
700, 704, 705 and 714, all as shown on this map within this
subdivision and subject to the conditions set forth thereon.



BE IT FURTHER RESOLVED, that said Council hereby acknowledges receipt of assurance from the subdivider, TIME CO., a partnership, that said subdivider will comply with the Affirmative Marketing Program as outlined in Document No. 763699, on file in the office of the City Clerk, and in reliance on said assurance does hereby accept the final map of MIRADOR UNIT NO. 4.
