APPROVING MAP OF PLAZA MAYOR UNIT NO. 2 SUBDIVISION

JUL 24 1978

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

Said Council hereby finds that that certain map surveyed by W. R. NOTHOMB, a Licensed Land Surveyor, entitled "PLAZA MAYOR UNIT NO. 2 Being a subdivision of portions of Lots 9 through 16, inclusive, all of Lots 17 and 18, and portions of Lots 31 and 32, in Block 16 together with portions of Louisiana Avenue and an alley in Block 16 as dedicated to public use together with an alley in Block 16 as closed and vacated to public use, all in Tia Juana City, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 562, filed in the office of the County Recorder of said County, August 29, 1888.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Avenida Camiones, Louisiana Avenue and the alley for public purposes; and said streets and alley are hereby declared to be public streets and a public alley and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal



corporation, the easements with the right of ingress and egress for the construction and maintenance of drainage facilities as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets and alley are accepted on behalf of the public as heretofore stated; and that that certain easement for drainage facilities, as granted and shown on this map, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
