

RESOLUTION NO. 221426 (R.79-52)

WHEREAS, Section 1930 of the Streets and Highways Code provides a procedure for the summary vacation of streets by City Council resolution where that portion to be vacated has been superseded by relocation; and

WHEREAS, that portion of an unimproved alley in Block 16, Tia Juana City, has been relocated by the approval on this date of the dedication of street system within the subdivision to be known as PLAZA MAYOR UNIT NO. 2; and

WHEREAS, those properties adjoining that portion of the alley in Block 16, Tia Juana City, to be vacated will continue to have access or will be accessible by the streets which have been dedicated with the approval on this date of the subdivision to be known as PLAZA MAYOR UNIT NO. 2; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:


1. That the alley in Block 16, Tia Juana City, as more particularly shown on Drawing No. 14196-B on file in the office of the City Clerk as Document No. 764207, which said drawing is attached hereto and made a part hereof, be and the same is hereby ordered vacated.

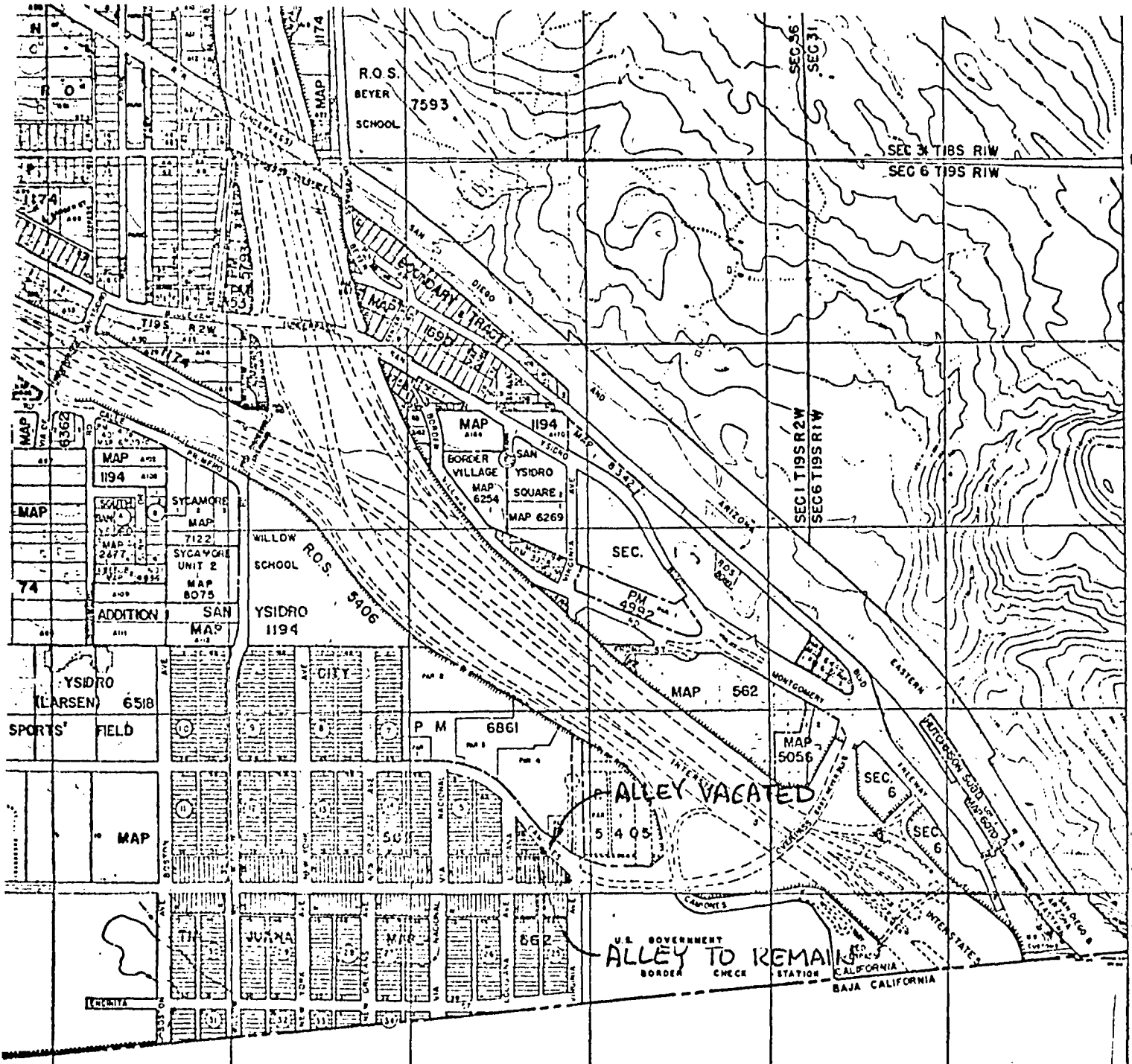
