BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the petition for the improvement of the ALLEY, BLOCK 16, CENTER ADDITION TO LA JOLLA PARK (between Girard Avenue and Herschel Avenue, and Pearl Street to Deadend), under the provisions of the Improvement Act of 1911, consisting of one sheet and filed under Document

No. 764208, is hereby granted.

BE IT FURTHER RESOLVED, that the City Manager be, and he is hereby directed to prepare plans, drawings, typical cross-sections, profiles and specifications for the improvement of the ALLEY, BLOCK 16, CENTER ADDITION TO LA JOLLA PARK, in the City of San Diego, by the grading and paving of the alley section with turn-around (right-of-way required), together with estimates of the costs and expenses of such work and to furnish this Council with a description of the district to be included in the assessment for the work and improvements hereinabove mentioned.
