

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a Use and Occupancy Permit with the UNITED STATES DEPARTMENT OF COMMERCE, NATIONAL WEATHER SERVICE, as Permittee, for the purposes of providing services for radio transmitting and receiving operations and all purposes incidental thereto, for a term of five years, at a monthly rental of \$244.20, under the terms and conditions set forth in that Permit on file in the office of the City Clerk as Document No. 764257.
